Subject

High-bit-rate Transceivers for Radiation-Hard Applications

Detailed Description

Silicon photonics (SiPh) shows considerable potential as a radiation-hard technology for building high-speed optical transmission links to send data across radiation-rich environments, e.g., space, nuclear power plants and particle physics detectors. In the last decade, preliminary results have shown that SiPh circuits can effectively operate in environments with large ionizing radiation, such as it is expected in high-energy physics experimental runs. State-of-the-art SiPh transceivers are nowadays designed and qualified for commercial terrestrial optical systems, while SiPh-based high-speed transceivers operation in radiation-rich is not yet well explored.

The goal of the proposed research activity will be the investigation of radiation tolerance in custom SiPh devices and systems to be operated in experiments which require tens of Gb/s data bandwidth.

Method of Execution

The collaborator will act independently although progress meetings will be scheduled with the Scientific Manager and other members of the project team. The collaborator will have to carry out the activities at the CNIT Research Unit of Photonic Networks and Technologies's National Laboratory, Via Moruzzi n.1, 56124 Pisa (PI), and will be able to use the equipment made available by the Consortium.
